The 37th Annual Oil Capital Bowling Tournament - Rules and Regulations

USBC Sanctioned - Open Division and Women's Division 2007

1. This tournament has 2 divisions, Open Division and Women's Division. Open Division open to men and women, Women's Division open to women bowlers only. Each participant must be a current USBC member. This tournament will be governed by the USBC playing rules. All bowlers must have paid their sanction fee for the 2007-2008 season. Affiliate membership and participation fees may be paid at the tournament site.
2. The prize ratio for Team, Doubles and Singles will be one (1) prize for every ten entries. The prize ratio for all events will be one (1) for every 20 entries. All Jackets and prize money will be awarded within thirty (30) days after the conclusion of the tournament.
3. Minimum Entering Average is 140. Handicap will be 75% of 220 per bowler. Each bowler will use their highest yearbook average of the past 2 seasons 2005-2006 or 2006-2007 with a minimum of 21 games. If no yearbook average is published, verification from your local USBC association will be required. When bowlers do not have a winter season average for the past 2 years, 2005-2006 or 2006-2007 averages established in a certified summer league, which started after March 15th 2007 shall be accepted. If summer 2007 average is used, send a final league sheet of 21 games or more with entry. No YABA average will be accepted. Ten pin rule does not apply in this tournament. No current average will be used in this tournament. All others will bowl scratch. Note: Only two (2) Professional Bowlers per team or one (1) per Doubles team will be allowed.
4. Rules 319d - Items 1,2 & 3 will be strictly enforced. Failure to comply shall cause forfeiture of all entry fees, scores and prize money if his/her average is higher than the one submitted on the entry form.
5. Rule 319a (3), 319c and 319e - The average of a bowler may be re-rated and must be accomplished at the time of entry, but if the re-rated average is not accepted by the bowler, the entry fee shall be refunded. It shall be the bowler's responsibility to verify the accuracy of his/her average whether originally submitted by the bowler, his/her team captain or others. Failure to use proper average shall disqualify score if submitted average is lower than actual average, thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average if it is higher than the actual average.
6. All bowlers under 220 average must comply with rule 319d. A bowler who has qualified for a prize of \$600.00 or more in any event in a tournament within the previous 12 month period must report in writing his/her actual score, position and amount won to the Tournament Management at the time of entry for possible re-rating. Failure to comply with this provision shall be cause to forfeit tournament entry fee and prize winnings. It is the bowler's responsibility to report his/her scores in any tournament where the prize payment has not been made but in which he/she has qualified for \$600.00 or more.
7. Jackets will be awarded to the Team, Doubles, Singles and All Events Champions. All entry fees must be paid prior to bowling to be eligible for any and all prizes. In the case of a tie, the money will be divided. In the case of a tie for a jacket, duplicate jackets will be awarded.
8. All errors must be corrected by the tournament management within 24 hours after the event was bowled. All protest must be made in writing prior to the time that the prize monies are paid. In the event of a mechanical failure, it is hereby agreed that the bowlers affected shall be moved to the next available pair of lanes. Bowlers will be allowed 5 minutes practice in teams and singles, and no practice in doubles.
9. Early reservations are encouraged by writing or calling the tournament office. However, entry closing date is Monday October 1, 2007. If all fees have not been received by the tournament office on or before the closing date, October 1, 2007, the reservations will be declared void and will be used to accommodate the first request received. The prize fund will be returned 100% in each event. No entry will be accepted unless accompanied by the entry fee. No entry fee will be returned after October 12, 2007.
10. All substitutions or any changes in the original entry or schedule must be made with the tournament manager one (1) hour prior to bowling each event. Emergency substitutions may be made five (5) minutes prior to the start of the squad. Individuals must bowl both singles and doubles or neither. Employees of AMF will be eligible to participate in the tournament. Entry blanks must be completed showing all necessary information. Failure to provide all information requested will result in forfeiture of any prizes won.
11. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto and therefrom, fires, strikes, lockouts, labor difficulties or other reasons beyond the control of the management of this tournament shall cause the foregoing prize schedules to be pro-rated in accordance with the number of entrants who have bowled in each of the respective events up to the time of termination.
12. The tournament management reserves the right to reject any entry and cancel this event with the return of entry fee.
13. An estimated prize list will be posted along with the USBC certification certificate.
14. Bowlers may enter the Team Event twice, providing not more than three members of the original team bowls on the second entry. When multiple participation is permitted, the bowler's first appearance in each event shall count as their "All Events" total, unless otherwise provided in the tournament rules (rule317). No bowler will be permitted to enter more than once in the Doubles and Singles events.
